## Little Priest Tribal College

Students transferring into Briar Cliff University's Accounting program are required to have completed the accounting, Associate of Science degree from Little Priest Tribal College with at 2.0 cumulative GPA.

Little Priest Tribal College Liberal Arts, Associate of Science students may begin Briar Cliff University's Bachelor of Arts business administration degree after completing 62 credits. Students from Little Priest Tribal College will need to complete 62 credits additional credits at Briar Cliff University in order to meet the graduation requirement of 120 credits.
