The required coursework provides the student with the minimum educational requirements to sit for the Uniform Certified Public Accountant examination and other similar professional accounting certifications. The student will

Major course work has been designed to build on the student's liberal arts foundation coursework that emphasizes reading, writing, mathematics, research, critical thinking and problem-solving.
